We appreciate that you, our members and attendees, understand the importance of professional and respectful conduct at the meeting. Our sciences and Societies are stronger for the positive discourse and interactions among all of us. And we honor the uniqueness that we each bring to our sciences and Societies.

To ensure an inclusive and positive environment, we are committed to providing an experience where diversity is celebrated and where everyone feels respected and has a sense of belonging. We will not tolerate any form of harassment or discrimination and will regard any that might happen as a serious matter.

What is considered harassment? It includes the following:

- Offensive comments or behaviors related to ethnicity, religion, disability, age, economic status, physical appearance, gender, or sexual orientation.
- Inappropriate physical contact, unwelcome comments or attention, deliberate intimidation, stalking, following, harassing photography or recording, and/or sustained disruption of talks or other events.

ASA, CSSA, and SSSA prohibit this conduct, even if done unintentionally, at any Society function. This <u>Code of Conduct</u> applies to speakers, attendees, volunteers, and staff. At the discretion of the Society leadership, participants violating these rules may be asked to leave the meeting.

In addition, please take a few minutes to watch our new video on <u>Professionalism in our Societies</u>, by Dr. Canul. She provides a bit of information on developing rewarding interpersonal relationships and share a few guidelines on how to minimize misunderstandings.

To ensure that the meeting is a positive experience for everyone, we all need to take responsibility. So, if you see something, SAY something. This year, we will again have a **DEI and Safe Space Advocate**. An advocate is one who supports and provides confidential assistance.

Our advocate is Dr. Kathleen Canul who will be onsite to talk with any attendee who would like to report an incident at the meeting (or post meeting) or provide comments (including positive comments) or feedback on our DEI efforts
